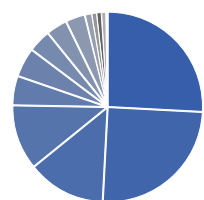
ABOUT THE FUND

WHY INVEST IN WSKY?

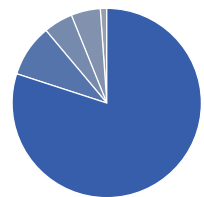
